This panel will examine the effect of the imposition of economic sanctions to address international peace and security concerns, gross violations of human rights, and significant foreign corruption. Topics proposed include the legal authorities for the imposition of sanctions; interpretative issues and uncertainties; recourse for listed, named or designated persons and others unwittingly caught by sanctions regimes; and the efficacy of these measures in advancing Canada's national security interests, including enforcement activities.
